A. General provisions

Art. 1 Organization

1.1 The issue and operation of online Instant Ticket Products (subsequently Online Instant Ticket Products "Clix") is governed by the Federal Act on Gambling of 29 September 2017, the implementing ordinance of 7 November 2018 related to this Act and the corresponding intercantonal and cantonal lottery regulations.

1.2 Swisslos, a cooperative domiciled in Basel, organizes Online Instant Ticket Products "Clix" in the territory of German-speaking Switzerland¹, Ticino and the Principality of Liechtenstein (collectively the "Swisslos Contract Territory") in accordance with these General Terms of Participation for Online Instant Ticket Products "Clix".

1.3 Draws are conducted electronically by Swisslos using certified equipment.

1.4 Swisslos issues Game Rules for the individual Online Instant Ticket Products "Clix" together with a prize structure and any rules for supplementary games. In the event of any conflicts, the rules for the supplementary games take priority over the specific Game Rules.

1.5 Online Instant Ticket Products "Clix" are sold exclusively via the Swisslos Internet Gaming Platform (subsequently "ISP"). Trading in Online Instant Ticket Products "Clix" is reserved to Swisslos; it is prohibited to third parties.

1.6 The present General Terms of Participationn for Online Instant Ticket Products "Clix" supplement the Rules of Play and Terms and Rules for Internet Games in force.

B. Nature of Online Instant Ticket Products "Clix"

Art. 2 Nature of Online Instant Ticket Products "Clix"

2.1 All lotteries with Online Instant Ticket Products "Clix" are identified by letters and/or numbers so that they can be referred to unambiguously.

2.2 Online Instant Ticket Products "Clix" are sold sealed.

C. Participation

Art. 3 Participation

The purchase of Online Instant Ticket Products "Clix" is subject to registration on the Swisslos ISP in accordance with the General Terms of Participation for Internet Games. The General Terms of Participation for the Online Instant Ticket Products "Clix" and the General Terms of Participation for Internet Games must be accepted by the player prior to the initial purchase of Online Instant Ticket Products "Clix". In concluding a Gaming Contract with Swisslos for the purchase of an Online Instant Ticket Product "Clix", the player automatically and unreservedly also recognizes the Game Rules for the Online Instant Ticket Product "Clix" purchased, as well as the prize structure and any rules for supplementary games. Furthermore, the player accepts that, in the event of a cash

prize, Swisslos may publish on swisslos.ch their first name, the first letter of their last name, and the first letter of the town where they live.

D. Final provisions

Art. 4 Operating licences

The licences to issue and operate Online Instant Ticket Products "Clix" granted in compliance with the applicable lottery legislation and in accordance with these General Terms of Participation, together with the associated activities, apply solely to Swisslos itself (Art. 1.2).

Art. 5 Validity

5.1 These General Terms of Participation for Online Ticket Products "Clix", the Game Rules applicable to the individual Online Instant Ticket Products "Clix" as well as the rules for supplementary games govern only participation in the various Online Instant Ticket Products "Clix" in the Swisslos Contract Territory. They enter into force on 1 October 2022. Swisslos reserves the right to amend these General Terms of Participation for Online Instant Ticket Products "Clix", the specific Game Rules and the rules for supplementary games.

5.2 Where the English, French or Italian version of the General Terms of Participation for Online Instant Ticket Products "Clix" deviates from the German version, the German version alone is binding.

5.3 The General Terms of Participation for the individual Online Instant Ticket Products "Clix", the Game Rules for the individual Online Instant Ticket Products "Clix" as well as the rules for supplementary games can be obtained from Swisslos, P.O.
